periodically have Jane Steere act as a consultant for that office at the rate of \$30 per hour. I foresee the need to be for a few hours at a time only sporadically over the next few months, at a total cost of \$450 - \$600. The department's budget for FY25 can support this expense.

It was an honor to identify myself as the prosecutor for the town every time I appeared in court. Likewise, it was rewarding to have served as counsel to the Zoning Board, which also enjoys a fine reputation.
